PUBLIC FORUM

A member of the public advised the meeting that HGV traffic along East Halton Road was still as bad as ever – there are many foreign drivers using this road/route illegally and unfortunately there is an awful lot of litter and waste thrown from the vehicles which needs clearing from the verges and hedges. Clerk to ask Andy Tate at N.L.C to arrange another litter pick/clear up. The flashing speed awareness signs should be picking up data regarding the illegal vehicles passing along this route however it is disappointing to note that no Police enforcement – although promised in June – has taken place.

A meeting with N.L.C representatives and martin Vickers MP has been arranged for this Friday 14th September at 11.30am in Hewson House, Brigg – Cllr's Broddley and Robinson will attend this meeting which is primarily to discuss the problem of the waste on the airfield.

The meeting was advised that the flypast at next years 550 squadron celebration will take place over the Church to prevent holding up traffic.

The irregularity of speed along East Halton Road/Top Road was discussed and it was agreed that making the full length of the road – from the roundabout at South Killingholme through East Halton to 40mph was a sensible solution. Clerk to speak to Ian Jickells at N.L.C to ask if this is feasible.

The clerk advised the meeting that – subject to funding being In place – work will commence on the two public footpaths shortly. The bridge is to be repaired but the repairs to the 'kissing gate' are still outstanding.

- i) Application PA/2018/1125 Planning permission to stockpile 170,000 tonnes of road salt at a maximum height of 10m to be secured with waterproof sheeting Land North West of Salfina warehouse, Lancaster House, Lancaster Approach, North Killinghjolme.
- **IT WAS RESOLVED** to **OBJECT** to this application expressing concerns regarding the pollution of the surface and ground drainage system due to the inadequacy of detail as to how the salt pile is sited and covered. It was also agreed to insist that the salt pile should be removed whilst the necessary planning permissions are in place.
- ii) Application PA/2018/1331 Planning permission to erect a single storey workshop building SMT GB, Lancaster Approach, North Killingholme.
- **IT WAS RESOLVED** to report **NO OBJECTIONS** to this application but to ensure that a condition of planning is that reasonable hours of construction are adhered to.

- iii)Landscape Award Hales and Coultas have been paid in full just waiting for the final grant payment to arrive. This then completes the project.
- iv)To give consideration to painting the village hall it was agreed that quotes would be sought to decorate the village hall, varnish/refurbish the front door, remove the old electric heaters and associated wires and make a loft hatch. The clerk advised that a grant application to the N.L.C community pot would be in order once the quotations have been received.

18/61 North Lincolnshire Council Matters

- i) Reports from N.L.C representatives: Cllr Hannigan advised the meeting that Environmental Health Officers from N.L.C, 2 Ward Officers and a South Killingholme Parish Councillor visited the site on the airfield where the waste is stored and found no evidence that the flies are originating from this area. N.L.C are endeavouring to find the source of the flies but this is proving very difficult. A meeting wil Martin Vickers MP is being held on Friday 14th September to discuss the problem of the waste disposal and there is some hope that the Environmental Agency may pick up the bill for its disposal.
- ii) Traffic/Highways Roy Hindmarsh has provided traffic data taken from the 'golden rivers' to councillors and residents. The result of this data has allowed 2 flashing speed awareness signs to be erected from September 2018 April 2019 when hopefully enforcement will start.
- iii)Flashing Speed awareness signs The two flashing speed awareness signs have been erected on East Halton Road unfortunately one sign near Garden Village is on the wrong side of the road (due to no power on the otherside) and this does make the sign function incorrectly on occasions. It is hoped that power will be provided on the 'correct' side of the road and the sign changed over to ensure this sign is functioning to its best. The clerk has asked Roy Hindmarsh to quote for the purchase of one of these signs.

The promised donations to purchase a speed awareness sign have now been received.

- iv)Blocked Drains The drains have been jetted to try to clear them of the silt and oil and investigations are under way to try and establish where the oil getting into the drainage system is coming from.
